and the following voted against the same: None

whereupon said resolution was declared duly passed and adopted.

Motion by Noska, second by Bentz and carried to approve to set the 2024 organizational meeting for January 8, 2024 at 6:00 P.M.

Motion by Noska, second by Hillmer to close the meeting to discuss negotiations with the Browerville Education Association at 6:50. The motion passed. The meeting was reopened at 7:18. Mr. Vedbraaten reported about the discussion.
